

## **Specific Privacy Statement**

**« Study to assess requests for a renewal of seven (-7-) exemptions 18(b), 18(b)-I, 24, 29, 32 and 34 of Annex III and exemption 34 of Annex IV of Directive 2011/65/EU”; the study was updated by an additional task to evaluate further requests for a renewal of exemptions 5(b) and 34 of Annex III.»**
